

**Information pursuant to Arts. 13 and 14 of EU Regulation 2016/679**  
**(This document consists of 2 pages)**

Dear Colleague, in compliance with the provisions of current legislation, we inform you of the following:

***a) Purposes of the collection and processing of data***

The personal data you provide us with are collected by ISODARCO for purposes of organizational, administrative and accounting management, and for all other purposes related to registration as Participant at an ISODARCO course. No other personal data will be collected in addition to those supplied by you. There is no profiling activity based on your data, neither on the part, nor on behalf of ISODARCO.

***b) Methods of data collection and processing***

Data collection and processing is carried out by Authorized Staff of ISODARCO, using paper and electronic tools, in compliance with current legislation and in accordance with the principles of correctness, lawfulness, protection of your privacy and your rights. In particular:

1. the data you provide in your registration form will be kept in electronic and paper form in the ISODARCO *archives* until the possible dissolution of ISODARCO; they will be used for statistical purposes and for all organizational purposes, including any law enforcement requirement of Italian Authorities;
2. should you participate in an ISODARCO event a copy of your *surname, name* and *affiliation* will be published in the *web pages* of the event, in the ISODARCO *web site* until the possible dissolution of ISODARCO. Should you wish not to be mentioned you should inform us and we will comply;
3. under your explicit consent, a copy of your *surname, name, affiliation* and any other information you wish and you provide ISODARCO with (e.g. contact information, professional and cultural interests, URL of personal web page), will be included in the *Participant List* of the event, to be distributed, in paper, to all and only the Participants at the event;
4. under your explicit consent, a copy of your *email address* you provided us with (or *email addresses*, in case you have provided us with more than one), together with your *surname* and *name*, will be kept until the possible dissolution of ISODARCO in the *electronic address books* of the email services used by the ISODARCO Staff for communicating with Participants;
5. for reasons of availability and continuity, back-up copies of ISODARCO *archives, web site, address books* and *mailing lists* will be kept until the possible dissolution of ISODARCO.

***c) Subjects to whom data can be communicated***

Your data may be communicated to other subjects exclusively for the purposes of carrying out the organizational and administrative procedures of ISODARCO and of the event and related legal and tax obligations.

***d) Data transfer to a third country or international organizations***

Your data will in no way be transferred to third countries. Your data is stored in the Isodarco computers and the server of Roma2-INFN and its access is protected by password available only to ISODARCO staff. ISODARCO is doing its best to prevent third party access to this data.

***e) Rights of the data subject***

You enjoy all the rights of the data subject enshrined in the EU Regulation and, in particular, you have at any time:

- the right of access, pursuant to Art. 15 of the EU Regulation;
- the right to rectification, pursuant to Art. 16 of the EU Regulation;
- the right to erasure (“right to be forgotten”), pursuant to Art. 17 of the EU Regulation;
- the right of restriction of processing, pursuant to Art. 18 of the EU Regulation;
- the right to data portability, pursuant to Art. 20 of the EU Regulation;
- the right to object, pursuant to Art. 21 of the EU Regulation;
- the right to withdraw consent;

Furthermore, if you believe that your data have been treated illegitimately, you have the right to contact the Supervisory Authority to propose a complaint.
